1. Do not include any information which could identify the company on any page except the first general information page. This page is removed before applications are sent to judges to keep the judging fair and anonymous. Please answer all questions in a separate file.
2. Include any appropriate documents that may help provide the judges a more complete picture of the leadership role the company plays in Bay County.

There is no cost to apply for the award for members of the Bay County Chamber of Commerce. There is a \$50 application fee for future-members. Application fee must be paid when submitting the application.

III. MISCELLANEOUS. Each criterion is evaluated based on the company's size and industry category to give both small and large companies an equal opportunity for recognition. All information provided must be accurate and verifiable.
